

## ADVERTISEMENT FOR BIDS

Sealed proposals will be received by the Division of Public Works, State of Idaho, at 1118 F Street, Room B11, Lewiston, Idaho 83501 until 10:00 am, prevailing local time, on **Tuesday, December 17, 2013** for DPW Project No. 12065 Phase II (Re-Bid), Window Replacement, North Idaho Correctional Institute (NICI), Idaho Department of Correction, Cottonwood, Idaho.

A description of the work of this project can be summarized to remove the existing aluminum, vinyl, and wood windows on Units 2,3, & 4 (Bldgs. 2, 3 and 15) and replace with new vinyl windows with tempered glazing. The existing cement fiberboard exterior trim and flexible flashing is to be removed at window demolition locations. Install new cement fiberboard exterior trim at new windows. Paint new trim. Provide new insulated panels as indicated for Agency installed window mounted air conditioning units. All interior repair and trim work to be completed by the Agency.

Window replacement for buildings 1,10, 11, 12, 16, & 18 shall be bid as separate alternates. Alternates are as follows:

- (1) Unit 1 (Bldg 1)
- (2) Building "C" / Laundry (Bldg. 10)
- (3) School (Bldg 11)
- (4) Gymnasium (Bldg 12)
- (5) Administration (Bldg 16)
- (6) Maintenance Shop (Bldg 18)
- (7) Install agency provide A/C units in insulated panels

Proposals will be opened and publicly read at the above hour and date.
