Heat Recovery Unit connected to the building central exhaust system; connect existing hoods to building central exhaust system. 1st floor VAV Box replacement with Hot Water Re-heat and new DDC controls. Remove existing fume exhaust fans from the roof and connect hoods to the existing manifold fume exhaust system with venture control valve. Phoenix Valve Upgrade from pneumatic to Electronic control. New intermediate filter bank at SF-1 serving 1st floor space. Re-build of intermediate Filter Bank SF-3 and FES-1. Remove existing perchloric fan and hood.
