Sealed proposals will be received by the Division of Public Works, State of Idaho, at **502 N. 4th St., PO Box 83720, Boise, Idaho 83720-0072 until 2:00 pm**, prevailing local time, on **Thursday, July 24th, 2014 for DPW Project 14213 Playground Remodel, Children's Center, Boise State University, Boise, Idaho.**

A description of the work of this project can be summarized to include: a base bid of removal of existing groundcover and hardscape from the existing west play areas and providing an underground drainage system, new play surfaces and the construction of shading structures. Alternates are included to provide additional underground drainage systems, play surfaces, hardscape, fencing, shading structures at the balance of the site and playground equipment for all locations on the site.
