Sealed proposals will be received by the Division of Public Works, State of Idaho, at Idaho State University, Maintenance & Operations Office, 749 E. Humbolt, Pocatello, Idaho 83209 until **2:00 pm**, prevailing local time, on **Tuesday, September 2, 2014** for **DPW Project 14245 RE-BID Replace Roof, Fine Arts Building, Idaho State University, Pocatello, Idaho.**

A description of the work of this project can be summarized to include removal of approximately 22,000 square feet of existing PVC single ply roofing including all insulation to existing roof deck and replace with a fully adhered single ply roofing membrane over rigid insulation. Install roof complete with all flashings, coping, etc. to provide a watertight roof. Remove existing water damaged vermiculite roof as required to install new roofing system.

Proposals will be opened and publicly read at the above hour and date.
