Sealed proposals will be received by the Division of Public Works, State of Idaho **Lewiston State Office at 1118 F Street – 3rd floor DPW Office** until **2:00 pm**, local time, on **Wednesday, July 19, 2023** for **DPW Project No 23353**, Repair Parking Lot, Lewiston, Department of Health and Welfare, Lewiston, Idaho.

A description of the work for this project can be summarized to include parking lot rehabilitation and site improvements at the Department of Health and Welfare facility. This includes: the reconstruction of two parking islands, new construction of three parking islands, curb adjustments, chip seal, concrete sidewalk, striping and pedestrian facilities upgrades, as detailed in the project documents. This work includes asphalt removal, asphalt patching, curb demolition and reconstruction, chip seal, striping, and installment of rock mulch. There are also a few concrete pads and a rubber mat in the designated recreation area to the south of the building which will be removed.

Proposals will be opened and publicly read at the above hour and date.
