Sealed proposals will be received by the Division of Public Works, State of Idaho, at **502 N. 4th St., PO Box 83720, Boise, Idaho 83720-0072** until **2:00 p.m.** local time, on **Thursday, July 27, 2023** for **DPW Project 23355 DHW: Re-Roof Aspen, Pine, Birch Client Units, SWITC, Nampa, Idaho.**

A description of the work of this project can be summarized to include the removal of the existing asphalt shingles, underlayment, valley metal, pre-manufactured ridge vent and roof jacks at all roof penetrations. Install new asphalt shingles over new underlayment, waterproof underlayment at roof eave, valleys and vertical wall transitions, new pre-finished metal valley flashing, roof jacks and pre-manufactured ridge vent.
