A description of the work of this project can be summarized to include provision and installation of emergency natural gas shutoff valves and appropriate controls located at designated egress locations.

The scope of work includes the items shown below:

- Emergency gas shutoff valves with electronic actuators
- Piping modifications to accommodate valves
- Emergency pushbutton switches located at points of egress
- Power and control wiring for valve activation
