Sealed proposals will be received by the Division of Public Works, State of Idaho, at **502 N. 4th St., PO Box 83720, Boise, Idaho 83720-0072** until **2:00 p.m.** local time, on **Wednesday, March 6, 2024** for **DPW Project 21622 Repair Roof Warden's House, Old Pen, Idaho State Historical Society, Boise, Idaho.**

A description of the work of this project can be summarized to include Remove existing gutters and stockpile for reinstallation. Remove and dispose of existing wood shingles, metal valley, wall and step flashing and metal cap at chimney. Install new wood shingles over new underlayment, new pre-finished metal valley, wall and step flashing and new metal cap around chimney. Reinstall gutter and seal seams. At dormers remove existing wood wall shingles and dispose, install new wood shingles to match existing style and profile over air/vapor barrier.

Proposals will be opened and publicly read at the above hour and date.
