Sealed proposals will be received by the Division of Public Works, State of Idaho, at the **Lewiston State Office Building, 1118 "F" Street, 3rd Floor DPW Office, Lewiston, Idaho 83501** until **1:00 p.m.** local time, on **Tuesday, May 28, 2024** for **DPW Project 24352 Replace Fire Lane Asphalt, State Hospital North, Department of Health & Welfare, Orofino, Idaho.**

A description of the work of this project can be summarized to include: Milling and overlay of approximately 400-feet of existing asphalt roadway/drive aisle. Asphalt pavement section removal of approximately 300-feet of existing asphalt roadway/drive aisle. Work expected to include traffic control, pedestrian control, asphalt saw cutting, asphalt pavement removal, installation of erosion control measures, road base fine grading, clean-out valve box and catch basin adjustments and topographic survey of installed asphalt pavement. The project may involve additional work for soft spot repairs and pavement repairs. Extents of the additional work are unknown and will be field determined by the geotechnical engineer.

Proposals will be opened and publicly read at the above hour and date.
