Sealed proposals will be received by the Division of Public Works, State of Idaho, at **DPW Field Office located on 875 Perimeter Drive, MS 2281, Moscow, Idaho 83844-2281** until **2:00 p.m. (PT) local time**, on **Tuesday, October 15th, 2024**, for **DPW Project No. 23255 New Elevator / Access Improvements, Hartung Theater, University of Idaho**, 625 Stadium Drive, Moscow, ID 83844.

A description of the work of this project can be summarized to include construction of a building addition to include a new elevator hoistway, vestibule, and installation of a three-stop machine roomless traction elevator. In addition, a new accessible concrete walk will be constructed from the street right of way to the new entry and elevator. Work is to include, but not limited to, selective demolition, site excavation, concrete work, steel and metal stud framed addition, metal siding, roofing, door and windows, interior finishes, electrical, mechanical, and fire sprinkler.
