including a crumbling foundation, rotten floor and roof joists, and other structural failures. The demolition will remove the house entirely and leave a flat vacant lot. There are no immediate plans for the use of this lot. The work will be performed under a miscellaneous contract.

The demolition cost estimate is \$29,500; and the project budget is \$30,500.

This project will improve the University of Idaho frontage on State Highway 8 from Stadium Drive to Line Street in Moscow, Idaho. The project limits are defined by State Highway 8 to the north, Stadium Drive to the west, Line Street to the east, and the Paradise Creek Ecosystem and Riparian Zone to the south.

A Request for Qualifications was issued on September 11, 2024. Responses were received from five landscape architects / civil engineers on October 1, 2024. A Selection Committee including Celine Acord and Craig Carson, UI, Anne Hanenburg, SPVV Independent Landscape Architect and Ken Cook and Elaine Hill, DPW. Two firms were interviewed on October 29, 2024.

The scope of this project is a continuation of the recently completed DPW Project No. 21250 that provided for the replacement of the domestic water system main and for the repairs and replacement of Idaho Avenue from the Kibbie Dome to the Facility Services building. The basis of this new project is a set of scope items which were bid as add alternates in the previous project, but which were unable to be funded at that time. This work generally includes a masonry gateway structure, UI standard banner poles, and additional enhanced landscaping with planters, street trees and irrigation. This scope was designed and detailed in the construction documents for DPW 21250.

DPW and UI are requesting to use Bernardo Wills Architects along with Keller Associates for this new project based on provisions of Idaho Statute §67-2320 which allows a public agency to "negotiate an extended or new professional services contract" with a firm that has been "previously awarded a professional services contract for an associated or phased project." Bernardo Wills and Keller designed the original documents and have the design and details in hand. We desire to continue with the same design firm to provide continuity, consistency, and continuation of the same type of architectural features. DPW and UI can achieve significant efficiencies and savings by making use of the services of the team which led the former project.

DPW Project Manager: Sydnee Weersing

This project will remodel an area (approximately 1,500 s.f.) inside the Edminster Student Union Building on the 2nd floor to accommodate a new American Indian student service area and student learning space. The space will include a conference room, an office, a kitchen area, and student learning space for team and individual collaboration.

Once programming began, NIC realized that the original request of 700 s.f. was too small thus they are increasing the square footage and adding agency funds.

Regional Architect, Architects West, Coeur d'Alene, has designed the project. The firm's construction cost estimate is \$498,359; and the project budget is currently \$210,000. NIC has committed to adding \$400,000 of agency funds to complete the build-out. This will bring the total project funding to \$610,000.

Ms. Bravo shared plans and presented the project.

DPW Project Manager: Sydnee Weersing

Originally built in 1976, Hedlund Hall, on the NIC campus in Coeur d'Alene, was designed to house career technical education programs such as diesel mechanics, auto mechanics, auto body, machining, classrooms, and office space. Most of these programs moved to the Parker Technical Education Center, in Rathdrum, when it opened in 2017. Since then, Hedlund Hall has become more oriented towards collaborative programs and activities including the Idaho Small Business Development Center, Gizmo, Coeur d'Alene's Makerspace, the Venture Center, Avista Center for Entrepreneurship, Computer Science, and the Culinary Arts Program.

This project will remodel approximately 8,550 s.f., of existing diesel bay space to accommodate a flexible space for lecture seating, worktable seating, or presentations for up to 200 occupants. The new space will also require support areas like administration offices, classrooms, storage, additional plumbing facilities, additional parking, etc. Some of these items will be included in a second phase of this project, due to budget restrictions.

The Design Professional, Architects West, Coeur d'Alene, has designed the first phase of this project. The construction cost estimate for the base bid is \$1,902,841 and the project's construction budget is \$2,770,000. Several bid alternates will be included in the final design to be accepted as the budget allows.

DPW Project Manager: Darius Ellison

The scope of work for this project is to build new office space at the State of Idaho, Chinden Campus in Boise for the Office of Information Technology Services. This Agency is growing due to statewide consolidation and requires a larger footprint to support the work of their agency.

The project will build a secure suite on the entire second floor (58,255 SF) of the currently vacant second floor of Building 4. It will create an entry lobby and reception/service desks, management offices, huddle, conference area, install doors and security access hardware; replace flooring, ceilings and other finishes; upgrade to LED lighting and upgrade HVAC systems and controls; provide power and data to support workstations, IT connectivity and wireless access. The project will renovate and upgrade core rooms for use as a break area, mail/workroom, and board rooms for the agency. A new electrical room will also be created. The Agency will provide all furnishings and technology separately.

McAlvain Design Build with CSHQA and Musgrove Engineering, Boise have designed the project. The firm's construction cost estimate for the work is \$6,891,382 (\$118/sf); the project original construction budget was \$6,250,000. Additional funding will be added to the project as needed to award the contract.

Council discussed the continued enhancement of the fire alarm system and Ms. Berard in response to Council's question, clarified that this was not the original space to be renovated for ITD.

The scope of this project has been to replace the cement roof tiles on LCSC's Reid Centennial Hall. In 2021, a proposal request from a service contractor was higher than the budget. Further investigation led to additional work that was not originally anticipated, including improvements to the structural supports that are aged and previously damaged in a fire. Also, while reviewing conditions on site, the design professional recommended repointing masonry because numerous areas were deficient and nearing critical failure.

In an effort to repair all known damages and address high bids, additional deferred maintenance funds were added to the project. Additional construction documents were required which delayed the project.

The project has recently been re-approved by DOPL and K&G Construction, Lewiston has provided an updated cost proposal through their light construction service contract. The Not-To-Exceed cost proposal for this work is \$190,000 and that fits within the current total project budget of \$203,000.
