Sealed proposals will be received by the Division of Public Works, State of Idaho, at **502 N. 4th St., PO Box 83720, Boise, Idaho 83720-0072** until **10:00 a.m.** local time, on **Friday, January 30, 2026** for **DPW Project 25211: EMA (Bldg. 015) Surveillance System, Boise State University, Boise, Idaho.**

A description of the work of this project can be summarized to include: Adding new surveillance cameras and associated system throughout the interior public area, at exterior entrances and on the Southeast and Northeast corners of the roof at ExtraMile Arena on Boise State University Campus. Replace existing security cameras on level 1 and on the roof and add two existing PTZ cameras at the balcony level above the catwalk area over the arena seating. New cameras will be installed in circulation areas, entries and in areas where transactions occur. Patch and repair of existing finishes and fireproofing. Fire caulk at penetrations through fire rated assemblies.

Proposals will be opened and publicly read at the above hour and date.
