A description of the work of this project can be summarized to include the Boise Annex Building to relocate eight employee workstations from the basement to the first floor, fostering more cohesive work groups. Additionally, the remodel will include the creation of new office spaces and the installation of a new interior communicating stairway between the first and second floors.
