Sealed proposals will be received by the Division of Public Works, State of Idaho, at **611 Wilson Ave. #1, Pocatello ID 83201** until **11:00 a.m.** local time, on **Thursday, March 5, 2026** for **DPW Project 24233 McIntosh Manor Fire Lane Retaining Wall Repairs, Idaho State University, Pocatello, Idaho**

A description of the work of this project can be summarized to include: Removal of the deteriorated asphalt paths throughout the site and replace with new concrete sidewalks. Removal of a portion of the existing poorly drained fire lane and replace with new paving, curb and gutter, and drain system. Regrade and install terraced retaining walls between Buildings D and E. Project also includes new storm drains, and replacement of existing concrete stairs and railings. Regrade and install a terraced retaining wall system behind the Laundry/Maintenance Building.

Proposals will be opened and publicly read at the above hour and date.
