Box 83720, Boise, Idaho 83720-0072** until **11:00 a.m.** local time, on **Tuesday, June 23, 2026** for **DPW Project 26111 RE-BID, Residential Cottages Fire Suppression System Replacement, Idaho Education Services for the Deaf and Blind, Gooding, Idaho.**

A description of the work of this project can be summarized to include the existing dry fire suppression systems in six residential cottages at the School for the Deaf and Blind have deteriorated due to pinhole leaks and failing piping and valves. This project will replace the failing infrastructure with modern, code-compliant fire suppression systems integrated into the existing buildings to minimize disruption. The improvements will enhance life safety, reduce maintenance issues, and support the school's mission to provide safe residential facilities.
